Next, is that I would like to request that the paragraph below accompany all future statements to me. Ideally, I would propose that this paragraph be printed in a prominent portion of the Statement so that it is extremely clear to members that they can simply subtract this amount when submitting their payment.

The paragraph I am referring to is as follows:

"Please note, ARDA is entirely voluntary, and does not affect your vacation ownership. As explained previously, should you elect not to contribute to this organization, simply omit the specified contribution amount from your payment and the balance will automatically be removed from your account, shortly after the due date."

At this time, I would like to also ask if there has been any progress on the \$45.39 credit on account amount that has gone missing? (see info in previous email thread at the bottom of this email)

With respect to the ARDA-ROC voluntary contribution, I would like to suggest that this was added NOT by our HOA but rather, by a BOD that was weighted in favour of DRI by means of Proxy votes assigned to DRI supporters that ran for election to the BOD. All that you have to do to verify this, is check the ballots cast in the last BOD elections and then check to see how those winning BOD candidates cast their votes on this issue.

In my opinion, this is a scam and a deal that was made between Stephen J. Cloobeck and ARDA for whatever reasons, and I plan to pursue this further.

There is no way that a BOD controlled by DRI can make a decision that affects all of the minority interests as broadly as this decision does.

Please advise your legal department to conduct themselves accordingly.
