Shortly, owners will soon be receiving a "Notice of Annual Meeting" form (by regular mail or email depending on what you asked for) which will include a Proxy Ballot to be used for electing new Board Members.

We would respectfully ask that you observe the following guidelines:

- **Please **DO NOT** sign your proxy over to the Board of Directors, as they will simply vote themselves back in.**
- **Please **DO** plan to vote, by one of the following methods:**
 - **Read the Candidate Summaries carefully, and choose who you think would be a good candidate - we recommend anyone supported by COPP**
 - **If you prefer, you can assign your vote to a Proxy Holder of your choice or, a Proxy Holder that we will identify in a later Newsletter.**

As noted above, and as soon as we have received the Notice, we will be following up with a Newsletter with complete instructions on how to complete your Proxy Ballot so please wait for this Newsletter before deciding what to do.

Last, is that we are looking for a volunteer that will be at Poipu and who is planning to attend the Annual Meeting. We need someone to carry our Proxy Ballots to the meeting and vote them as a block, for the candidate of our choice.
